### AAM Use Cases in Texas

### **Existing:**

 Drone package delivery—groceries/Rx/food (Frisco / College Station / Hillview)

#### Near term:

- Disaster supply delivery
- Regional airport to larger airport eVTOL shuttle
- Regional hubs to tourism destination eVTOL shuttle (Arlington)
- Regional taxi rides eVTOL shuttle (Brownsville)

#### Longer term:

- Greenfield vertiports in rural areas
- Shuttle equipment and people to remote work sites

## **Community Integration Factors**

	Community receptivity		Other factors to consider
Drone package delivery			Education about what different aircraft types see (package drones are not taking pictures of the ground)
Disaster supply delivery			
Airport VTOL shuttle			Logical use of the aircraft, but make sure it is clear that this isn't the only use
Tourism VTOL shuttle	Perception that this is for richer people only		Easier to build AAM infrastructure than other types, like roads/rails
VTOL taxi rides			
Greenfield vertiports			
Remote site VTOL people/cargo shuttles			Creates economic opportunities for previously isolated communities
All AAM	Public concern with safety, privacy		Big demand for electricity

### Port San Antonio Use Case Discussion

- Infrastructure development models including where private and public financing can work together [example – burying utility lines is millions of dollars with the utility looking to the field operator to pay and no clear path to monetization]
- Showcasing eVTOL operations in real world campus in public view [our Boeing Center at Tech Port is regional entertainment and education venue located in center of 18,000-person air industrial and research park meaning that operations can be had in controlled environment with existing residential, commercial, and industrial operations]
- Showcasing value of AAM beyond traditional air taxi model [our campus has potential early adopters and a present and growing need for AAM as transportation augmentation]
