For example, we would like to use projects completed by our subsidiaries where the Project Manager, Construction Manager and Construction Quality Assurance Manager served as key personnel. Please revise the RFQ language to allow for projects performed by wholly owned and controlled subsidiaries to be included on Forms E-1, E-2, and E-3. Existing text: "In order for the project experience provided in the QS to be considered responsive, Forms E-1, E-2, E-3 shall list only projects for which the corporate entity (company, joint venture, partnership or consortium) providing engineering, construction, or maintenance experience is respectively the Equity Member, Lead Engineering Firm, Lead Contractor, or Lead Capital Maintenance Firm itself (as those terms are defined in Part B, Volume 1). Project experiences provided by a parent or sister	The experience of a subsidiary of an Equity Member or Non-Major Equity Member will be considered if the Equity Member or Major Non-Equity Member has management control over the subsidiary. Part A, Section 5.1 of the RFQ will be revised in Addendum #1 as follows: "In order for the project experience provided in the QS to be considered responsive, Forms E-1, E-2, E-3 shall list only projects for which the corporate entity (company, joint venture, partnership or consortium) providing engineering, construction, or maintenance experience is respectively the Equity Member, Lead Engineering Firm, Lead Contractor, or Lead Capital Maintenance Firm itself or a controlled subsidiary of such Equity Member, Lead Engineering Firm, Lead Contractor, or Lead Capital Maintenance Firm (as those terms are defined in Part B, Volume 1). As the current RFQ is written, several of the proposers will not be able to write a 4 page Executive Summary, 5 page Management Structure, and a 5 page Statement of Technical Approach because they have more than one Equity Member. This puts teams with multiple equity member at a disadvantage. Please exclude	The page limitation applies to all components of Volume 1, including the Transmittal Letter and Legal Qualifications. The page limitation for Volume 1 will be increased to 40 pages in Addendum #1 to the RFQ.
