The undersigned ("Proposer") submits this proposal (this "Proposal") in response to that certain Request for Proposals (the "RFP") issued by the Texas Department of Transportation ("TxDOT"), an agency of the State of Texas, dated April 26, 2013, as amended, to design and construct the Loop 1604 Western Extension Project (the "Project"), as more specifically described herein and in the documents provided with the RFP (the "RFP Documents").
