Given the remainder of written sections in the RFQ total 17 pages, Proposer believes this is a more appropriate summary length. 1 page is also consistent with a recent TxDOT RFQ, procured under the Programmatic documents.	The page limit for the Executive Summary will be reduced to a maximum of 5 pages.

For Oak Hill Parkway, the Executive Summary has a stated maximum length of 10 pages. This appears excessive since the rest of the narratives within the SOQ are 17 pages total. Is this number correct?	The page limit for the Executive Summary will be reduced to a maximum of 5 pages.
