The HSP organizes anticipated grants into focus-oriented program areas. This minute order lists the number of grants in each program area and the allocated amounts for Fiscal Year 2025.*

Amendments to §§6.2-6.4, 6.12, 6.23, 6.32, 6.41-6.43, and 6.45 concerning the State Infrastructure Bank ([MO](#))

*The proposed amendments provide conforming changes to Texas Transportation Code, Chapter 222, Subchapter D, clean-up of outdated provisions, clarify the intent of multiple sections, and provide efficiencies for the department and borrowers.*

(2) **Chapter 11 - Design**

The repeal of §§11.200 - 11.221 the federal Transportation Enhancement Program ([MO](#))

*This minute order proposes the repeal of §§11.200 - 11.221 as the federal Transportation Enhancement Program has been replaced by the Transportation Alternatives Program in the federal Moving Ahead for Progress in the 21st Century Act in 2012 and with sections §§11.300 - 11.317 in the TAC. No new projects have been submitted under the program since August 2012, nor authorized for funding under the program since August 2016.*

(3) **Chapter 12 - Traffic Operations**

Amendments to §§12.351 - 12.355 concerning sponsorships of the roadside assistance and safety service patrol programs ([MO](#))

*The proposed amendments add roadside assistance and safety service patrols to the state acknowledgment program, which allows the department to acknowledge donations for highway-related services.*

(4) **Chapter 25 - Traffic Operations**

The repeal of §25.27 and enactment of new §25.27 concerning the variable speed limit program ([MO](#))

*The proposed amendments repeal original §25.27, which concerned a variable speed limit (VSL) pilot program that expired in 2015, and enact new §25.27, which implements a new VSL program authorized by House Bill 1885, 88th Legislature, 2023, Regular Session. The VSL program sets the conditions under which the department may temporarily lower a prima facie speed limit to address inclement weather, congestion, road construction, or any other condition that affects the safe and orderly movement of traffic on a roadway.*

*The proposed changes will align the rules with amendments made by House Bill No. 3444, Acts of the 88th Legislature, Regular Session, 2023, relating to the classification of department districts.*

*Commission findings, determinations, and authorizations for the state, by motion made in accordance with Senate Bill 18 (82nd Legislature), to acquire by eminent domain, upon the payment of adequate and just compensation, various ownership interests in specific parcels of real property that are needed to develop or improve both non-controlled and controlled access state highways, to include requesting the state attorney general to bring and pursue condemnation suits relating to those specific parcels of real property described in the attached itemized list.*

*State statutes require the commission to acknowledge the acceptance of a gift to the department that is valued at \$500 or more. By the adoption of this minute order, the commission acknowledges the receipt and acceptance of the property specified in the minute order.*  
b. **Real Estate Dispositions**  
*The commission must approve the sales, transfers, and exchanges of state rights of way and other real properties that are no longer needed for a state highway purpose. It must also approve, accept, and acknowledge donations to the state of real property that is valued at \$500 or more.*
- 116725 (1) **Bastrop County** - SL 230 - Consider the sale of right of way to the city of Smithville, Texas ([MO](#))  
*The district has determined that the land is no longer needed for highway purposes. The city of Smithville has requested to purchase the land, and it may be sold to the city.*
- 116726 (2) **Midland County** - SL 250 - Consider the sale of right of way to an abutting landowner ([MO](#))  
*The district has determined that the land is no longer needed for highway purposes. An abutting landowner has requested to purchase the land, and it may be sold to the requester.*
- 116727 (3) **Travis County** - SH 130 - Consider the designation of one location on the SH 130 southbound frontage road at which access will be permitted to the adjoining private real property ([MO](#))  
*The designation of one 19.00-foot break in the control-of-access line will allow the adjoining landowner to open one driveway for ingress only from the SH 130 southbound frontage road. The district has determined that access may be permitted at the designated location.*

*State law requires the commission to establish a compliance program, which must include a Compliance Division to oversee the program. The Compliance Division is responsible for acting to prevent and detect serious breaches of department policy, fraud, waste, and abuse of office, including any acts of criminal conduct within the department. The Compliance Division is required to provide a monthly report to the commission regarding investigations and a summary of information relating to trends and recommendations.*
- (2) **Environmental Report**  
Consider the acceptance of the report on projects being processed under the procedures of Transportation Code, Chapter 201, Subchapter I-1 ([Report](#))  
*The report identifies projects with a local government sponsor being processed under the environmental review procedures set forth in Transportation Code, Chapter 201, Subchapter I-1. A report must be submitted twice a year to the commission, as required by Transportation Code, §201.762(a).*
- d. **Rail Clearance Deviations**
- 116728 (1) **Bexar County** - Consider the approval of rail clearance deviations ([MO](#))  
*This minute order authorizes approval of applications for rail clearance deviations, which are waivers from clearance provisions for structures over and alongside railway tracks.*
- 116729 (2) **McLennan County** - Consider the approval of rail clearance deviations ([MO](#))  
*This minute order authorizes approval of applications for rail clearance deviations, which are waivers from clearance provisions for structures over and alongside railway tracks.*
- e. **Land Acquisitions for Facilities**
- 116730 **Various Counties** - Consider the grant of authority to the department to acquire real property for facilities ([MO](#))  
*The department is in the process of acquiring real property for the construction of new facilities and the expansion of existing facility sites. Funds for the purchase of these properties were appropriated by the 88th Legislature, General Appropriations Act for the 2024-25 Biennium. The department requests the commission's authorization to enter into purchase contracts and related documents to complete the acquisition of the listed properties.*
