*The Gulf Intracoastal Waterway (GIWW) is an important component of the Texas multimodal transportation system. The Texas Department of Transportation acts as the non-federal sponsor of the GIWW and collaborates with the U.S. Army Corps of Engineers to maintain the GIWW. State law requires the Texas Transportation Commission to continually evaluate the impact of the GIWW on the state and to publish and present a report to each regular session of the legislature.*

**Cameron County** - Brownsville Navigation District - Consider approval of a request from Brownsville Navigation District for a Ship Channel Improvement Revolving Fund loan in the amount of up to \$43,000,000 to provide revenue or security for its local share of qualified costs necessary to widen or deepen the Brazos Island Harbor Channel in Cameron County, Texas ([MO](#))  
*The Brownsville Navigation District (district) will secure the loan with a subordinate lien pledge of net revenues. The loan will be used by the district to provide revenue or security for its local share of qualified costs necessary to widen or deepen the Brazos Island Harbor Channel.*

Consider the appointment of members to the Bicycle and Pedestrian Advisory Committee ([MO](#))  
*The Bicycle and Pedestrian Advisory Committee advises the Texas Transportation Commission on bicycle and pedestrian issues and matters of mutual concern between the Texas Department of Transportation (department) and the bicycling and pedestrian communities. By involving representatives of the public, including bicyclists, pedestrians, and other interested parties, the department helps ensure effective communication with the bicycling and pedestrian communities, and that the bicyclist's and pedestrian's perspective will be considered in the development of departmental policies related to bicycle use and pedestrian activity, including the design, construction, and maintenance of highways.*
- 116784 c. **Border Trade Advisory Committee**  
Consider the appointment of members to the Border Trade Advisory Committee ([MO](#))  
*This minute order appoints members to the Border Trade Advisory Committee. The purpose of the committee, created in 2001 by the 77th Legislature is to define and develop a strategy and make recommendations to the Texas Transportation Commission and the governor in order to address the highest priority border trade transportation challenges.*
- 116785 d. **Port Authority Advisory Committee**  
Consider the appointment of members to the Port Authority Advisory Committee ([MO](#))  
*This minute order approves the appointment of members to the Port Authority Advisory Committee to fill vacated terms. The purpose of the committee, created by state law, is to offer advice and recommendations that will provide the Texas Transportation Commission and the Texas Department of Transportation with a broad perspective regarding maritime ports and transportation-related matters to be considered in formulating department policies concerning the Texas maritime port system.*

- 116786 a. **Brazoria and Galveston Counties** - Consider the award of state and federal funds to the Gulf Coast Transit District ([MO](#))  
*The awards identified in this minute order reflect the allocation of fiscal year 2025 state rural funds and federal Section 5311 funds to the Gulf Coast Transit District for program eligible purposes.*

*The awards identified in this minute order reflect the allocation of fiscal year 2023 and 2024 federal Section 5339 funds and state funds to Rural Transit Districts, residual Section 5339 funds to a Rural Transit District, and federal funds to various entities that responded to the biennial Coordinated Call for Projects.*

*State law requires the internal auditor to create an annual audit plan that is prepared using risk assessment techniques and that identifies the individual audits to be conducted during the year. The internal audit plan must be approved by the Texas Transportation Commission (commission). In addition, the commission must review the resources dedicated to the Internal Audit Program and determine if adequate resources exist to ensure that risks identified in the annual risk assessment are covered in a reasonable timeframe.*

*Federal law authorizes the award of federal non-primary entitlement grant funding, federal apportionment grant funding, and Infrastructure and Investment Jobs Act grant funding to preserve and improve the state's general aviation system. State law authorizes the award of state grant funding for capital improvement projects.*

**Hidalgo County** - City of Donna - Consider final approval of a request from the city of Donna for a State Infrastructure Bank loan in the amount of up to \$35,920,000 to pay for the costs to construct inspection facilities, roadway, and other improvements to the Puente Donna Rio Bravo International Bridge in Hidalgo County, Texas ([Presentation](#)) ([MO](#))  
*The city of Donna (city) seeks financial assistance through the proposed purchase of \$35,920,000 city of Donna General Obligation Bonds with a pledge of ad valorem taxes as sufficient security for repayment of the bonds. The loan will be used to pay the city's costs to construct inspection facilities, roadway, and other improvements to the Puente Donna Rio Bravo International Bridge in Hidalgo County, Texas.*

a. **Rules Proposals**

(1) **Chapter 9 - Contract and Grant Management**

Amendments to §9.152, General Rules for Design-Build Contracts, and §9.153, Solicitation of Proposals, concerning Design-Build Contracts ([MO](#))

*The proposed amendments modify §9.153 to implement changes made to Transportation Code, §223.246 that require a request for proposals for a design-build project to include a design that is approximately 30 percent complete. The proposed amendments also modify §9.152 and §9.153 to clarify the department's right to suspend a procurement for a design-build project and to provide that a partial stipend may only be paid to a proposer that submits a proposal responsive to the requirements of the request for proposals or, if the procurement is terminated before receiving proposals, to pay for proposer work product requested by the department for use in the performance of department functions.*

(2) **Chapter 9 - Contract and Grant Management**

Amendments to §§9.2, 9.15, 9.17, 9.23, and 9.24 concerning contract claims and contracts for highway projects ([MO](#))

*The proposed amendments clarify the rules concerning the requirements for submitting certain claims for contracts entered into and administered by the Texas Department of Transportation (department). Additionally, amendments are proposed to allow the department to determine an apparent low bid nonresponsive if it is mathematically and materially unbalanced, clarify that interim contract performance evaluations are required on the anniversary of the date work began, and align terminology with the language used in 43 TAC §1.1 (Texas Transportation Commission).*

(3) **Chapter 13 - Materials Quality**

The repeal of §13.8 concerning testing asphalt ([MO](#))

*The proposed amendments repeal the obsolete requirements and procedure for the Texas Department of Transportation (department) to charge asphalt suppliers for the cost of sampling and testing asphalt that does not comply with the department's specifications.*

(4) **Chapter 21 - Right of Way**

Amendments to §21.25, Selection (Utility Adjustment, Relocation, or Removal) ([MO](#))

*Senate Bill 2601, 88th Legislature (S.B. 2601) amended Transportation Code, Chapter 203, Subchapter E, which sets out procedures for a utility to apply for state participation in the relocation of certain publicly owned utility facilities and by the Texas Department of Transportation and the Texas Transportation Commission in determining whether all or part of the expense of the relocation of the facility will be paid for by the state. The amendment allows water supply or sewer service corporations organized and operating under Chapter 67 of the Water Code to qualify for the program.*

(1) **Chapter 6 - State Infrastructure Bank**

Amendments to §§6.2-6.4, 6.12, 6.23, 6.32, 6.41-6.43, and 6.45 concerning the State Infrastructure Bank ([MO](#))

*The proposed amendments provide conforming changes to Texas Transportation Code, Chapter 222, Subchapter D, clean-up of outdated provisions, clarify the intent of multiple sections, and provide efficiencies for the Texas Department of Transportation and borrowers.*

(2) **Chapter 11 - Design**

The repeal of §§11.200 - 11.221 the federal Transportation Enhancement Program ([MO](#))

*This minute order proposes the repeal of §§11.200 - 11.221 as the federal Transportation Enhancement Program has been replaced by the Transportation Alternatives Program in the federal Moving Ahead for Progress in the 21st Century Act in 2012 and with sections §§11.300 - 11.317 in the TAC. No new projects have been submitted under the program since August 2012, nor authorized for funding under the program since August 2016.*

(3) **Chapter 12 - Public Donations and Participation Program**

Amendments to §§12.351 - 12.355 concerning sponsorships of the roadside assistance and safety service patrol programs ([MO](#))

*The proposed amendments add roadside assistance and safety service patrols to the state acknowledgment program, which allows the Texas Department of Transportation to acknowledge donations for highway-related services.*

(4) **Chapter 25 - Traffic Operations**

The repeal of §25.27 and enactment of new §25.27 concerning the variable speed limit program ([MO](#))

*The proposed amendments repeal original §25.27, which concerned a variable speed limit (VSL) pilot program that expired in 2015, and enact new §25.27, which implements a new VSL program authorized by House Bill 1885, 88th Legislature, 2023, Regular Session. The VSL program sets the conditions under which the Texas Department of Transportation may temporarily lower a prima facie speed limit to address inclement weather, congestion, road construction, or any other condition that affects the safe and orderly movement of traffic on a roadway.*

13. **Highway Designation**

**Lubbock County-** In Lubbock County, consider designating a segment of the state highway system as I-27, concurrent with US 87 ([Presentation](#)) ([MO](#))

*This minute order designates a segment of the state highway system as I-27, concurrent with US 87, from the existing I-27 terminus to 0.1 mile north of County Road 7500, a total distance of 4.2 miles. The Federal Highway Administration has approved the designation of this segment.*

14. **Municipal Utility Relocation Reimbursement**
- 116800 a. **Kleberg County** - Consider the approval of a request from the Riviera Water Control and Improvement District to make the relocation of the Riviera Water Control and Improvement District's utility facilities required by the US 77 highway improvement project an expense of the state under Transportation Code §203.092(a-4) ([MO](#))  
*Texas Administrative Code, Chapter 21, Subchapter B, Rule 21.25 sets forth the requirements for a utility to qualify for reimbursement under this program. Payment for this relocation will not cause the Texas Department of Transportation to exceed \$10 million in any fiscal year. The utility is a political subdivision with a financial condition that prevents the utility from being able to pay the cost in full or in part or, if paid at that time, the payment would adversely affect the utility's ability to operate or provide essential services to its customers. The utility is a political subdivision, or owned or operated by a political subdivision, that has a population of less than 5,000 and is located within a county that has been included in at least five disaster declarations made by the president of the United States of America in a period of six years preceding the proposed date of the relocation.*
- 116801 b. **San Patricio County** - Consider the approval of a request from the city of Gregory to make the relocation of the city of Gregory's utility facilities required by the SH 35 highway improvement project an expense of the state under Transportation Code §203.092(a-4) ([MO](#))  
*Texas Administrative Code, Chapter 21, Subchapter B, Rule 21.25 sets forth the requirements for a utility to qualify for reimbursement under this program. Payment for this relocation will not cause the Texas Department of Transportation to exceed \$10 million in any fiscal year. The utility is a political subdivision with a financial condition that prevents the utility from being able to pay the cost in full or in part or, if paid at that time, the payment would adversely affect the utility's ability to operate or provide essential services to its customers. The utility is a political subdivision, or owned or operated by a political subdivision, that has a population of less than 5,000 and is located within a county that has been included in at least five disaster declarations made by the president of the United States of America in a period of six years preceding the proposed date of the relocation.*
15. **Eminent Domain Proceedings**
- 116802 **Various Counties** - Consider the authorization of the filing of condemnation proceedings to acquire real property by eminent domain for non-controlled and controlled access highways (see attached itemized list) ([MO](#))  
*Texas Transportation Commission findings, determinations, and authorizations for the state, by motion made in accordance with Senate Bill 18 (82nd Legislature), to acquire by eminent domain, upon the payment of adequate and just compensation, various ownership interests in specific parcels of real property that are needed to develop or improve both non-controlled and controlled access state highways, to include requesting the state attorney general to bring and pursue condemnation suits relating to those specific parcels of real property described in the attached itemized list.*

16. **Routine Minute Orders and Reports**

a. **Donations to the Department**

116803

**Various Districts** - Consider the acknowledgment of donations with a value of \$500 or more, including donations of money, materials, services, or real property, that are made to the department for the purpose of assisting the Texas Department of Transportation in carrying out its functions and duties or for improving access to or from a highway on the state highway system (see attached itemized list) ([MO](#))

*State statutes require the Texas Transportation Commission (commission) to acknowledge the acceptance of a gift to the Texas Department of Transportation that is valued at \$500 or more. By the adoption of this minute order, the commission acknowledges the receipt and acceptance of the property specified in the minute order.*

b. **Real Estate Dispositions**

*The Texas Transportation Commission must approve the sales, transfers, and exchanges of state rights of way and other real properties that are no longer needed for a state highway purpose. It must also approve, accept, and acknowledge donations to the state of real property that is valued at \$500 or more.*

(1) **Bell County** - I-35 - Consider the sale of right of way to an abutting landowner ([MO](#))

*The district has determined that the land is no longer needed for highway purposes. An abutting landowner has requested to purchase the land, and it may be sold to the requester.*

116805

(2) **Brown County** - US 67 - Consider the exchange of a drainage easement as part of a transaction to acquire an access easement needed for a state highway purpose ([MO](#))

*The district has determined that the drainage easement to be released by the state in the exchange is no longer needed for a state highway purpose. The governor, on the recommendation of the commission, may execute an instrument exchanging an interest in real property acquired but not needed for a highway purpose as whole or partial consideration for another interest in real property needed for a state highway purpose.*

(3) **Williamson County** - Facility Site - Consider the sale of a facility site to Williamson County, Texas ([MO](#))

*The district has determined that the land is no longer needed for highway purposes. Williamson County (county) has requested to purchase the land, and it may be sold to the county.*

c. **Reports**

**Compliance Division Report**

*State law requires the Texas Transportation Commission (commission) to establish a compliance program, which must include a Compliance Division to oversee the program. The Compliance Division is responsible for acting to prevent and detect serious breaches of department policy, fraud, waste, and abuse of office, including any acts of criminal conduct within the Texas Department of Transportation. The Compliance Division is required to provide a monthly report to the commission regarding investigations and a summary of information relating to trends and recommendations.*

16. **Routine Minute Orders and Reports**
- 116807 d. **Release of Access**  
**Liberty County** - SH 105 Bypass, in the city of Cleveland - Consider the removal of control of access at two locations along the abutting property line from which access will be permitted at one point on the southbound side of SH 105 Bypass ([MO](#))  
*The designation of two breaks in the control-of-access line will allow the abutting landowner to open two driveways for ingress and egress from the property. These two driveways will be connected together, and a single driveway will connect to southbound SH 105 Bypass. The district has determined that access may be permitted at the designated location.*
- 116808 e. **Economically Disadvantaged Counties Program**  
**Various Counties** - Consider the certification of eligible counties for the 2025 Economically Disadvantaged Counties Program and establish local match adjustments for each county and certain cities ([MO](#))  
*State law requires the Texas Transportation Commission to annually certify economically disadvantaged counties as soon as possible after the comptroller reports on the relevant economic indicators. This minute order certifies the counties to participate in the Economically Disadvantaged Counties Program (program) for fiscal year 2025 and sets forth the local match adjustment for each county and certain cities participating in the program.*
- 116809 f. **Highway Designation**  
**Bastrop County** - In the county of Bastrop, consider designating FM Spur 1441 on the state highway system ([MO](#))  
*This minute order designates FM Spur 1441 on the state highway system along existing Old 1441 from FM 1441 northeastward to Green Valley Drive, a distance of approximately 0.2 miles.*
- 116810 g. **Speed Zones**  
**Various Counties** - Consider the establishment or alteration of regulatory and construction speed zones on various sections of highways in the state ([MO](#))  
*This minute order establishes or alters regulatory and construction speed zones on various sections of highways in the state.*
17. **Executive Session** Pursuant to Government Code, Chapter 551  
**Section 551.071** - Consultation with and advice from legal counsel regarding any item on this agenda, pending or contemplated litigation, or other legal matters.

**OPEN COMMENT PERIOD** - At the conclusion of all other agenda items, the Texas Transportation Commission will allow an open comment period, not to exceed one hour, to receive public comment on any other matter that is under the jurisdiction of the Texas Department of Transportation.
