6. **Design-Build Contract**

116850 Brazoria and Galveston Counties - Consider authorizing the Texas Department of Transportation to issue a request for qualifications to design, construct, and maintain the SH 99 Grand Parkway Segment B-1 Design-Build Project. The SH 99 Grand Parkway Segment B-1 Design-Build Project consists of two tolled lanes in each direction along SH 99 from south of FM 2403 to FM 646, and non-tolled operational improvements along SH 99 and SH 35 in Brazoria and Galveston counties (Presentation) (MO)

> On February 7, 2023, Brazoria and Galveston counties entered into agreements with the Texas Department of Transportation (department) pursuant to Chapter 373 of the Texas Transportation Code, wherein Brazoria County and Galveston County waived and declined to exercise their options to develop, construct, finance and operate the Segment B-1 of the Grand Parkway project in Brazoria and Galveston Counties. Transportation Code § 223.242 authorizes the department to enter into, in each state fiscal biennium, up to six design-build contracts for highway projects with a construction cost estimate of \$150 million or more. The purpose of this portion of the SH 99 Grand Parkway Segment B-1 is to improve system connectivity between suburban communities and major roadways, improve safety and mobility, accommodate economic development, and to provide an alternative emergency evacuation route to the greater Houston area. This project meets the requirements for design-build delivery.

Amendments to §21.25, Selection (Utility Adjustment, Relocation, or Removal) (MO)

Senate Bill 2601, 88th Legislature amended Transportation Code, Chapter 203, Subchapter E, which sets out procedures for a utility to apply for state participation in the relocation of certain publicly owned utility facilities and by the Texas Department of Transportation and Texas Transportation Commission in determining whether all or part of the expense of the relocation of the facility will be paid for by the state. The amendment allows water supply or sewer service corporations organized and operating under Chapter 67 of the Water Code to qualify for the program.
