The Texas Department of Transportation may reschedule receipt of bids for those projects where the Texas Transportation Commission (commission) rejects all bids. Those bids accepted by the commission will result in conditional contract awards to the low bidders. Contract award conditions may involve securing funding from other sources, the contractor's ability to satisfy federal DBE subcontracting requirements, or other requirements as outlined in the project bid proposal.*

5. **Aviation**

- 116929 **Various Counties** - Consider the award of federal non-primary entitlement grant funding, federal apportionment grant funding, Infrastructure and Investment Jobs Act grant funding, and state grant funding for airport improvement projects at various locations ([MO](#))

*Federal law authorizes the award of federal non-primary entitlement grant funding, federal apportionment grant funding, and Infrastructure and Investment Jobs Act grant funding to preserve and improve the state's general aviation system. State law authorizes the award of state grant funding for capital improvement projects.*

6. **Design-Build Contract**

- 116930 **Brazoria and Galveston Counties** - Consider authorizing the Texas Department of Transportation to issue a request for proposals to design, construct and maintain the SH 99 Grand Parkway Segment B-1 Design-Build Project and consider approving stipulated amounts as payment for the work product of unsuccessful proposers. The SH 99 Grand Parkway Segment B-1 Design-Build Project consists of two tolled lanes in each direction along SH 99 from south of FM 2403 to FM 646, and non-tolled operational improvements along SH 99 and SH 35 in Brazoria and Galveston counties ([MO](#)) ([Presentation](#))

*On February 7, 2023, Brazoria and Galveston counties entered into agreements with the Texas Department of Transportation (department) pursuant to Chapter 373 of the Texas Transportation Code, wherein Brazoria County and Galveston County waived and declined to exercise their options to develop, construct, finance, and operate the Segment B-1 of the Grand Parkway Project in Brazoria and Galveston counties. On December 17, 2024, in Minute Order 116850, the Texas Transportation Commission authorized the department to issue a request for qualifications to design, construct, and maintain the SH 99 Grand Parkway Segment B-1 Design-Build Project. This minute order was preceded by the designation of Segment B-1 as a toll project on the state highway system and this portion of the SH 99 Grand Parkway is being developed by the department under a market valuation waiver agreement executed in March 2009. This minute order continues the procurement process by authorizing the issuance of a request for proposals for the project and approves stipulated amounts for the payment of work product of responsive, unsuccessful proposers.*

- 116931 7. **Eminent Domain Proceedings**  
**Various Counties** - Consider the authorization of the filing of condemnation proceedings to acquire real property by eminent domain for non-controlled and controlled access highways (see attached itemized list) ([MO](#))  
*Texas Transportation Commission findings, determinations, and authorizations for the state, by motion made in accordance with Senate Bill 18 (82nd Legislature), to acquire by eminent domain, upon the payment of adequate and just compensation, various ownership interests in specific parcels of real property that are needed to develop or improve both non-controlled and controlled access state highways, to include requesting the state attorney general to bring and pursue condemnation suits relating to those specific parcels of real property described in the attached itemized list.*

*State statutes require the Texas Transportation Commission (commission) to acknowledge the acceptance of a gift to the Texas Department of Transportation that is valued at \$500 or more. By the adoption of this minute order, the commission acknowledges the receipt and acceptance of the property specified in the minute order.*
- 116933 b. **Real Estate Dispositions**  
*The Texas Transportation Commission must approve the sales, transfers, and exchanges of state rights of way and other real properties that are no longer needed for a state highway purpose. It must also approve, accept, and acknowledge donations to the state of real property that is valued at \$500 or more.*
- 116934 (1) **Cottle County** - FM 104 - Consider an easement release to the underlying fee owner ([MO](#))  
*The district has determined that the easement is no longer needed for highway purposes. The easement may be released to the underlying fee owner.*
- 116934 (2) **Harris County** - I-69 - Consider the sale of right of way to a governmental entity with the authority to condemn the property and the quitclaim of an interest that might have accrued to the state by use ([MO](#))  
*The district has determined that the land is no longer needed for highway purposes. A governmental entity with the authority to condemn the property has requested to acquire the land and it may be sold and quitclaimed to the requester.*
- 116935 (3) **Henderson County** - SH 198 - Consider the exchange of drainage easements as part of a transaction to acquire drainage easements needed for a state highway purpose ([MO](#))  
*The district has determined that the easements to be released by the state in the exchange are no longer needed for a state highway purpose.*

*The district has determined that the land is no longer needed for highway purposes. The local governmental entities declined to purchase the land and legal notice was posted for sale by sealed bid. A successful bidder has been identified and the land may be sold to the successful bidder.*
- 116937      (5) **Tom Green County** - US 67 - Consider the exchange of a drainage easement as part of a transaction to acquire a drainage easement needed for a state highway purpose ([MO](#))  
*The district has determined that the easement to be released by the state in the exchange is no longer needed for a state highway purpose.*

The Compliance Division is required to provide a monthly report to the commission regarding investigations and a summary of information relating to trends and recommendations.*
- (2) **Letting Allocation Report**  
Quarterly report on the Fiscal Year 2025-2026 letting allocation, the actual allocation utilized through the quarter, and proposed remaining highway maintenance and construction contract letting for the fiscal year ([Report](#))  
*This report will provide the current overall allocation status, by district and metropolitan planning organization, of the Fiscal Year 2025-2026 letting allocation and will also provide the anticipated effect on the letting allocation of remaining proposed highway maintenance and construction letting.*
- (3) **Quarterly Cash Report**  
Quarterly report on Fiscal Year 2025 State Highway Fund 6 cash activity ([Report](#))  
*This report updates the Texas Transportation Commission on the year-to-date cash balance and activity of Fund 6. The report will include original projections and actual revenues/inflows and expenditures/outflows on a cash basis.*
- 116938      d. **Speed Zones**
- Various Counties** - Consider the establishment or alteration of regulatory and construction speed zones on various sections of highways in the state ([MO](#))  
*This minute order establishes or alters regulatory and construction speed zones on various sections of highways in the state.*
