#### 7. **Aviation**

**Various Counties** - Consider the award of federal non-primary entitlement grant funding, federal apportionment grant funding, Infrastructure and Investment Jobs Act grant funding, and state grant funding for airport improvement projects at various locations (MO)

Federal law authorizes the award of federal non-primary entitlement grant funding, federal apportionment grant funding, and Infrastructure and Investment Jobs Act grant funding to preserve and improve the state's general aviation system. State law authorizes the award of state grant funding for capital improvement projects.

#### 8. Annual Grant Application for Highway Safety

**Various Counties** - Consider approval of funding for the Fiscal Year 2026 Annual Grant Application (<u>Presentation</u>) (<u>MO</u>)

The Texas Department of Transportation develops and implements an Annual Grant Application (AGA) to the National Highway Traffic Safety Administration (NHTSA) as part of the Triennial Highway Safety Plan. Federal funds are allocated by NHTSA and are used for traffic safety grants identified in the AGA. The AGA organizes anticipated grants into focus-oriented program areas. This minute order lists the number of grants in each program area and the allocated amounts for Fiscal Year 2026.

#### 9. State Infrastructure Bank

**Various Counties** - Consider approval of applications for State Infrastructure Bank loans from various applicants (<u>Presentation</u>) (<u>MO</u>)

This minute order will authorize the executive director or their designee to enter into a financial assistance agreement with each applicant pursuant to the terms of this minute order and 43 Texas Administrative Code Chapter 6.

### a. Chapter 7 - Rail Facilities

Proposes new §§7.120-7.134 relating to Financial Assistance for Rail (MO) New §§7.120 - 7.134, contained in new Subchapter G, describe the policies and procedures for the implementation and administration of the Off-System Rail Grade Separation State Fund Program as authorized by SB 1555 (89th Legislature, Regular Session, 2025) and codified at Texas Transportation Code §471.010.

#### b. **Chapter 25 - Traffic Operations**

Amendments to §25.1, Uniform Traffic Control Devices (MO)

This amendment revises the Texas Manual on Uniform Traffic Control Devices adopted by reference in §25.1 to substantially conform to the recently updated national Manual on Uniform Traffic Control Devices, as required by state and federal law.

#### 11. Eminent Domain Proceedings

**Various Counties** - Consider the authorization of the filing of condemnation proceedings to acquire real property by eminent domain for non-controlled and controlled access highways (see attached itemized list) (MO)

Texas Transportation Commission findings, determinations, and authorizations for the state, by motion made in accordance with Senate Bill 18 (82nd Legislature), to acquire by eminent domain, upon the payment of adequate and just compensation, various ownership interests in specific parcels of real property that are needed to develop or improve both non-controlled and controlled access state highways, to include requesting the state attorney general to bring and pursue condemnation suits relating to those specific parcels of real property described in the attached itemized list.

### 12. Routine Minute Orders and Reports

#### a. **Donations to the Department**

116963

Various Districts - Consider the acknowledgment of donations with a value of \$500 or more, including donations of money, materials, services, or real property, that are made to the Texas Department of Transportation (department) for the purpose of assisting the department in carrying out its functions and duties or for improving access to or from a highway on the state highway system (see attached itemized list) (MO)

State statutes require the Texas Transportation Commission (commission) to acknowledge the acceptance of a gift to the Texas Department of Transportation that is valued at \$500 or more. By the adoption of this minute order, the commission acknowledges the receipt and acceptance of the property specified in the minute order.

### 12. Routine Minute Orders and Reports (continued)

#### b. **Real Estate Dispositions**

The Texas Transportation Commission must approve the sales, transfers, and exchanges of state rights of way and other real properties that are no longer needed for a state highway purpose. It must also approve, accept, and acknowledge donations to the state of real property that is valued at \$500 or more.

(1) **Anderson County** - SH 294 - Consider the sale of right of way to an abutting landowner (MO)

The district has determined that the land is no longer needed for highway purposes. An abutting landowner has requested to purchase the land, and it may be sold to the requester.

(2) **Denton County** - FM 720 - Consider the sale of right of way to the town of Little Elm, Texas (MO)

The district has determined that the land is no longer needed for highway purposes. The town of Little Elm (town) has requested to purchase the land, and it may be sold to the town.

(3) **Hidalgo County** - I-2 - Consider the sale of right of way to the city of Weslaco. Texas (MO)

The district has determined that the land is no longer needed for highway purposes. The city of Weslaco (city) has requested to purchase the land, and it may be sold to the city.

### c. **Reports**

### (1) Compliance Division Report

State law requires the Texas Transportation Commission (commission) to establish a compliance program, which must include a Compliance Division to oversee the program. The Compliance Division is responsible for acting to prevent and detect serious breaches of Texas Department of Transportation (department) policy, fraud, waste, and abuse of office, including any acts of criminal conduct within the department. The Compliance Division is required to provide a monthly report to the commission regarding investigations and a summary of information relating to trends and recommendations.

#### (2) Environmental Report

Consider the acceptance of the report on projects being processed under the procedures of Transportation Code, Chapter 201, Subchapter I-1 (Report)

The report identifies projects with a local government sponsor being processed under the environmental review procedures set forth in Transportation Code, Chapter 201, Subchapter I-1. A report must be submitted twice a year to the Texas Transportation Commission, as required by Transportation Code, §201.762(a).

#### 12. Routine Minute Orders and Reports (continued)

d. Highway Designations

116967

(1) Collin County - In the city of McKinney and Collin County consider designating a segment of SS 399 and SH 5 concurrently; extending SS 399 on a new location from SH 5 to FM 546; designating a segment of SS 399 concurrently with FM 546 from Couch Drive southeastward to South Airport Drive; and designating SS 399 on a new location from South Airport Drive southeastward to a location west of County Road 317, then northeastward and northward to US 380 (MO) This minute order designates a segment of SS 399 concurrently with SH 5 from the junction of SH 5 northward approximately 0.5 miles; extends SS 399 on a new location on the state highway system from SH 5 eastward to FM 546, approximately 0.75 miles; designates a segment of SS 399 concurrently with FM 546 from Couch Drive southeastward to South Airport Drive, a distance of approximately 0.82 miles; and extends SS 399 on a new location from South Airport Drive southeastward to a location west of County Road 317, then northeastward and northward to US 380, a distance of approximately 3.8 miles.

(2) **Wichita County** - Consider the rescission of Minute Order 108918, dated May 30, 2002. This minute order designated a new location for SH 240, redesignated a segment of State Loop 267 as SH 240; and concurrently designated SH 240 along I-44. It also removed segments of SH 240, State Loop 267, and State Spur 383 from the state highway system (MO)

This minute order seeks to rescind the provisions outlined in Minute Order

108918, as detailed in exhibit A. The provisions were never executed by the Texas Department of Transportation, the designations were not incorporated into any roadway inventory database, and no corresponding signage was installed.

### e. Speed Zones

**Various Counties** - Consider the establishment or alteration of regulatory and construction speed zones on various sections of highways in the state (MO)

This minute order establishes or alters regulatory and construction speed zones on various sections of highways in the state.
