*These proposed minute orders contain information concerning the receipt of bids for highway improvement contracts. The Texas Department of Transportation may reschedule receipt of bids for those projects where the Texas Transportation Commission (commission) rejects all bids. Those bids accepted by the commission will result in conditional contract awards to the low bidders. Contract award conditions may involve securing funding from other sources, the contractor's ability to satisfy federal DBE subcontracting requirements, or other requirements as outlined in the project bid proposal.*

5. **Aviation**

**Various Counties** - Consider the award of federal non-primary entitlement grant funding, federal apportionment grant funding, Infrastructure and Investment Jobs Act grant funding, and state grant funding for airport improvement projects at various locations ([MO](#))

*Federal law authorizes the award of federal non-primary entitlement grant funding, federal apportionment grant funding, and Infrastructure and Investment Jobs Act grant funding to preserve and improve the state's general aviation system. State law authorizes the award of state grant funding for capital improvement projects.*

6. **Advisory Committee**

**Bicycle and Pedestrian Advisory Committee**

Consider the appointment of members to the Bicycle and Pedestrian Advisory Committee ([MO](#))

*This minute order approves the reappointment of current members and the appointment of new members to the Bicycle and Pedestrian Advisory Committee. The purpose of the committee is to advise the commission on bicycle and pedestrian issues and matters of mutual concern between the Texas Department of Transportation and the bicycling and pedestrian communities.*

7. **Promulgation of Administrative Rules** Under Title 43, Texas Administrative Code, and the Administrative Procedure Act, Government Code, Chapter 2001:

**Rule Adoption**

**Chapter 7 - Rail Facilities**

Adopts new §§7.120-7.134 relating to Financial Assistance for Rail ([MO](#))

*New §§7.120 - 7.134, contained in new Subchapter G, describe the policies and procedures for the implementation and administration of the Off-System Rail Grade Separation State Fund Program as authorized by Senate Bill 1555, 89<sup>th</sup> Legislature, Regular Session, 2025, and codified at Texas Transportation Code §471.010.*

8. **Fiscal Year 2026 Audit Plan**

Consider the approval of the Internal Audit Plan for Fiscal Year 2026 and determine whether adequate resources have been dedicated to the Internal Audit Program ([Presentation](#)) ([MO](#))

*State law requires the internal auditor to create an annual audit plan that is prepared using risk assessment techniques and that identifies the individual audits to be conducted during the year. The Internal Audit Plan must be approved by the Texas Transportation Commission (commission). In addition, the commission must review the resources dedicated to the Internal Audit Program and determine if adequate resources exist to ensure that risks identified in the annual risk assessment are covered in a reasonable timeframe.*

9. **Regional Mobility Authority**

**Webb County** - Approve the city of Laredo's request for an exception to the requirements of 43 TAC §26.51(b)(1)(A), concerning eligibility to serve as a director or chief administrative officer of a regional mobility authority, in connection with a member of the board of directors of the Webb County-City of Laredo Regional Mobility Authority appointed by the city of Laredo ([MO](#))

*Under Title 43 Texas Administrative Code §26.51(b)(1)(A), a person is not eligible to serve as a director or chief administrative officer of a regional mobility authority (RMA) if the person or the person's spouse is employed by or participates in the management of a business entity or other organization that is regulated by or receives funds from the Texas Department of Transportation, the RMA, or a member county. The city of Laredo (city) appointed Antonio "Tony" Arce, Jr. to the Webb County-City of Laredo (WC-CL) RMA board of directors. Mr. Arce serves as the chair of the board of directors of Gateway Community Health Center, a non-profit organization that receives funding from both the city and Webb County. The city has requested an exception to the requirements of 43 Texas Administrative Code §26.51(b)(1)(A) because of the city's belief that Mr. Arce's service in this non-compensated role does not in any way compromise his ability to serve the interests of the WC-CL RMA. Gateway Community Health Center provides comprehensive primary health care services to the residents of Webb County. Staff have reviewed the city's request and determined that the conditions for Texas Transportation Commission approval of an exception have been met.*

10. **Highway Designation**

**Liberty County** - Designate a segment of the state highway system as I-69, concurrent with US 59, from just north of the Montgomery-Liberty County line to the new limit of access control on U.S. Highway 59 at the northern end of the Cleveland Relief Route ([Presentation](#)) ([MO](#))

*This minute order designates an 8-mile segment of the state highway system as I-69, concurrent with US 59. This segment is part of High Priority Corridors 18 and 20, as designated by congress in the Intermodal Surface Transportation Efficiency Act of 1991, as amended. The Federal Highway Administration and the American Association of State Highway and Transportation Officials have approved the designation of this segment as a logical addition to the Interstate System.*

11. **Transportation Corporations**

**Various Counties** - Appoint a director to the board of directors of the Grand Parkway Transportation Corporation, the Texas Private Activity Bond Surface Transportation Corporation, and the Texas Transportation Finance Corporation ([MO](#))

*The Texas Transportation Commission (commission) is required by law to appoint directors to the board of directors of each transportation corporation that the commission creates. This minute order appoints a director to each corporation's board of directors to fill a vacancy left by a director who has retired from employment with the Texas Department of Transportation.*

12. **Eminent Domain Proceedings**

**Various Counties** - Consider the authorization of the filing of condemnation proceedings to acquire real property by eminent domain for non-controlled and controlled access highways (see attached itemized list) ([MO](#))

*Texas Transportation Commission findings, determinations, and authorizations for the state, by motion made in accordance with Senate Bill 18, 82<sup>nd</sup> Legislature, Regular Session, 2011, to acquire by eminent domain, upon the payment of adequate and just compensation, various ownership interests in specific parcels of real property that are needed to develop or improve both non-controlled and controlled access state highways, to include requesting the state attorney general to bring and pursue condemnation suits relating to those specific parcels of real property described in the attached itemized list.*

13. **Routine Minute Orders and Reports**

a. **Donations to the Department**

**Various Districts** - Consider the acknowledgment of donations with a value of \$500 or more, including donations of money, materials, services, or real property, that are made to the Texas Department of Transportation (department) for the purpose of assisting the department in carrying out its functions and duties or for improving access to or from a highway on the state highway system (see attached itemized list) ([MO](#))

*State statutes require the Texas Transportation Commission (commission) to acknowledge the acceptance of a gift to the Texas Department of Transportation that is valued at \$500 or more. By the adoption of this minute order, the commission acknowledges the receipt and acceptance of the property specified in the minute order.*

13. **Routine Minute Orders and Reports (continued)**

b. **Real Estate Dispositions**

*The Texas Transportation Commission must approve the sales, transfers, and exchanges of state rights of way and other real properties that are no longer needed for a state highway purpose. It must also approve, accept, and acknowledge donations to the state of real property that is valued at \$500 or more.*

- (1) **Dallas County** - SH 183 - Consider the sale of real property to the city of Irving, Texas ([MO](#))

*The district has recommended that the Texas Transportation Commission determine that the land is no longer needed for highway purposes. The city of Irving (city) has requested to purchase the land, and it may be sold to the city.*

- (2) **El Paso County** - SL 375 - Consider the exchange of real property as part of a transaction to acquire real property needed for a state highway purpose ([MO](#))

*The district has recommended that the Texas Transportation Commission (commission) determine that the land to be conveyed by the state in the exchange is no longer needed for state highway purposes. The governor, on the recommendation of the commission, may execute a deed exchanging an interest in real property acquired but not needed for a highway purpose as whole or partial consideration for another interest in real property needed for a state highway purpose.*

- (3) **Lamar County** - FM 1507 - Consider an easement release to the underlying fee owner ([MO](#))

*The district has recommended that the Texas Transportation Commission determine that the easement is no longer needed for highway purposes. The easement may be released to the underlying fee owner.*

- (4) **Tarrant County** - FM 157 - Consider the sale of right of way to the city of Mansfield, Texas ([MO](#))

*The district has recommended that the Texas Transportation Commission determine that the land is no longer needed for highway purposes. The city of Mansfield (city) has requested to purchase the land, and it may be sold to the city.*

- (5) **Travis County** - SH 130 - Consider an easement release to the underlying fee owner ([MO](#))

*The district has recommended that the Texas Transportation Commission determine that the easement is no longer needed for highway purposes. The easement may be released to the underlying fee owner.*

- (6) **Wharton County** - FM 102 - Consider the removal from the highway system, transfer of jurisdiction, control, and maintenance, and transfer of right of way to the city of Wharton, Texas ([MO](#))

*The district has recommended that the Texas Transportation Commission determine that a segment of roadway is no longer needed as part of the highway system. The city of Wharton (city) has agreed to assume jurisdiction, control, and maintenance and has requested that the right of way be transferred to the city. The right of way may be transferred to the city without cost to remain in use for public road purposes and will revert to the state if it ceases to be used for public road purposes, if the unrestricted motor vehicle lanes are reduced in number or width, or if the capacity of the roadway is reduced at all.*

13. **Routine Minute Orders and Reports (continued)**

b. **Real Estate Dispositions (continued)**

- (7) **Wilbarger County** - US 70 & US 287 - Consider the exchange of drainage easements as part of a transaction to acquire a drainage easement needed for a state highway purpose ([MO](#))

*The district has recommended that the Texas Transportation Commission (commission) determine that the drainage easements to be conveyed by the state in the exchange are no longer needed for a state highway purpose. The governor, on the recommendation of the commission, may execute an instrument exchanging an interest in real property acquired but not needed for a highway purpose as whole or partial consideration for another interest in real property needed for a state highway purpose.*

- (8) **Williamson County** - SH 130 - Consider the designation of one location on the SH 130 northbound frontage road at which access will be permitted to and from the adjoining private real property ([MO](#))

*The designation of one 30.01-foot break in the control-of-access line will allow the adjoining landowner to open one driveway for ingress to and egress from the SH 130 northbound frontage road. The district has determined that access may be permitted at the designated location.*

c. **Reports**

**Compliance Division Report**

*State law requires the Texas Transportation Commission (commission) to establish a compliance program, which must include a Compliance Division to oversee the program. The Compliance Division is responsible for acting to prevent and detect serious breaches of Texas Department of Transportation (department) policy, fraud, waste, and abuse of office, including any acts of criminal conduct within the department. The Compliance Division is required to provide a monthly report to the commission regarding investigations and a summary of information relating to trends and recommendations.*

d. **Economically Disadvantaged Counties Program Fiscal Year 2026**

**Various Counties** - Consider the certification of eligible counties for the Fiscal Year 2026 Economically Disadvantaged Counties Program; establish local match adjustments for each county and certain cities, and delegate the statutory reporting responsibility to the executive director or designee ([MO](#))  
*State law requires the Texas Transportation Commission to annually certify economically disadvantaged counties as soon as possible after the Texas Comptroller of Public Accounts reports on the relevant economic indicators. This minute order certifies the counties eligible to participate in the Economically Disadvantaged Counties Program (program) for Fiscal Year 2026 and establishes the local match adjustment for each county and certain cities participating in the program. This minute order also delegates the statutory reporting responsibility to the Texas Department of Transportation executive director or designee.*

13. **Routine Minute Orders and Reports (continued)**

e. **Highway Designation**

**Houston County** - In the city of Crockett, consider designating SH 7, SH 19, SH 21, and US 287 concurrently with SL 304 and redesignating segments of SH 7, SH 19, SH 21, and US 287 as BS 7, BS 19, BS 21, and BU 287 ([MO](#))

*This minute order designates portions of SH 7, SH 19, SH 21, and US 287 to run concurrently with SL 304 around the city of Crockett (city) and redesignates the existing alignments of these highways through the city, including segments along Goliad Avenue, 4th & 5th Streets, Houston Avenue, and Bowie Avenue, as business routes BS 7, BS 19, BS 21, and BU 287.*

f. **Speed Zones**

**Various Counties** - Consider the establishment or alteration of regulatory and construction speed zones on various sections of highways in the state ([MO](#))

*This minute order establishes or alters regulatory and construction speed zones on various sections of highways in the state.*

14. **Executive Session** Pursuant to Government Code, Chapter 551, **§551.071**  
Consultation with and advice from legal counsel regarding any item on this agenda, pending or contemplated litigation, or other legal matters.

**OPEN COMMENT PERIOD** - At the conclusion of all other agenda items, the commission will allow an open comment period, not to exceed one hour, to receive public comment on any other matter that is under the jurisdiction of the department. No action will be taken. Each speaker will be allowed a maximum of three minutes. Speakers must be signed up prior to the beginning of the open comment period.
