*The awards identified in this minute order reflect the allocation of federal Transportation Alternatives Set-Aside funds for selected infrastructure projects throughout the state to construct a variety of alternative transportation projects, including Americans with Disabilities Act/pedestrian infrastructure, on- and off-street bikeways, shared use paths, and active transportation planning documents.*

*This minute order will authorize adjusting the previously approved Public Parking Expansion Area project at Port Freeport from E Eighth Street to E Second Street. Rider 36 in the General Appropriations Act, 89<sup>th</sup> Legislature, Regular Session, 2025, authorizes the Texas Department of Transportation to provide funding in an amount not to exceed \$40,000,000 in the 2026-2027 biennium from any available source of revenue and/or balances in the Texas Mobility Fund No. 365 for public roadway projects selected by the Port Authority Advisory Committee and approved by the Texas Transportation Commission to improve connectivity to Texas ports.*

*These amendments extend the sunset dates for statutory and Texas Department of Transportation advisory committees and repeals provisions relating to the Advanced Air Mobility Advisory Committee, which was established and abolished by Senate Bill 2144, 88<sup>th</sup> Legislature, Regular Session, 2023.*
- 117077 b. **Chapter 25 - Traffic Operations**  
Adopts amendments to §25.1, Uniform Traffic Control Devices ([MO](#))  
*This amendment revises the Texas Manual on Uniform Traffic Control Devices adopted by reference in §25.1 to address changes in the recently updated national Manual on Uniform Traffic Control Devices, as required by state and federal law.*
- 117078 9. **Eminent Domain Proceedings**  
**Various Counties** - Consider the authorization of the filing of condemnation proceedings to acquire real property by eminent domain for non-controlled and controlled access highways (see attached itemized list) ([MO](#))  
*Texas Transportation Commission findings, determinations, and authorizations for the state, by motion made in accordance with Senate Bill 18, 82<sup>nd</sup> Legislature, Regular Session, 2011, to acquire by eminent domain, upon the payment of adequate and just compensation, various ownership interests in specific parcels of real property that are needed to develop or improve both non-controlled and controlled access state highways, to include requesting the state attorney general to bring and pursue condemnation suits relating to those specific parcels of real property described in the attached itemized list.*

*The district has recommended that the Texas Transportation Commission determine that the land is no longer needed for highway purposes. An abutting landowner has requested to purchase the land, and it may be sold to the requester.*

- (2) **Bee County** - SH 72 - Consider the rescission of Minute Order 116134, dated October 28, 2021, authorizing the release of an easement to the underlying fee owner ([MO](#))

*The counterparty failed to provide payment required to complete the release of the easement.*

- (3) **De Witt County** - FM 240 - Consider the removal from the system, transfer of jurisdiction, control, and maintenance, and transfer of right of way to the county of De Witt, Texas ([MO](#))

*The district has recommended that the Texas Transportation Commission determine that a segment of roadway is no longer needed as part of the system. DeWitt County (county) has agreed to assume jurisdiction, control, and maintenance and has requested that the right of way be transferred to the county. The right of way may be transferred to the county without cost to remain in use for public road purposes and will revert to the state if it ceases to be used for public road purposes.*

- (4) **Kendall County** - I-10 - Consider the rescission of Minute Order 116085, dated August 31, 2021, authorizing the release of an easement to the underlying fee owner ([MO](#))

*The counterparty failed to provide payment required to complete the release of the easement.*

- (5) **Tom Green County** - South Orient Railroad - Consider the sale of railroad right of way to an abutting landowner ([MO](#))

*The district has recommended that the Texas Transportation Commission determine that the land is no longer needed for Texas Department of Transportation purposes. An abutting landowner has requested to purchase the land, and it may be sold to the requester.*

- (6) **Travis County** - RM 2322 - Consider the exchange of drainage easements as part of a transaction to acquire a drainage easement needed for a state highway purpose ([MO](#))

*The district has recommended that the Texas Transportation Commission (commission) determine that the drainage easement to be conveyed by the state in the exchange is no longer needed for a state highway purpose. The governor, on the recommendation of the commission, may execute an instrument exchanging an interest in real property acquired but not needed for a highway purpose as whole or partial consideration for another interest in real property needed for a state highway purpose.*

*State law requires the Texas Transportation Commission (commission) to establish a compliance program, which must include a Compliance Division to oversee the program. The Compliance Division is responsible for acting to prevent and detect serious breaches of Texas Department of Transportation (department) policy, fraud, waste, and abuse of office, including any acts of criminal conduct within the department. The Compliance Division is required to provide a monthly report to the commission regarding investigations and a summary of information relating to trends and recommendations.*

(2) **Quarterly Investment Report**

Quarterly Investment Report for all of the funds invested at the direction of the Texas Transportation Commission ([Report](#))

*This is a presentation of the quarterly investment report for the investment of: (1) funds held by the Bank of New York Mellon, as trustee, under the Indenture of Trust securing the Central Texas Turnpike System toll revenue obligations; (2) funds for the custodial accounts under the Master Lockbox and Custodial Account Agreement held by the Bank of New York Mellon, acting as custodian; (3) funds held by Amegy Bank, a Division of ZB, National Association, as trustee, under the Trust Agreement securing the I-35E Managed Lanes Project toll revenue obligations; and (4) funds held by U.S. Bank National Association, as trustee, under the Master Trust Agreement securing the SH 249 System toll revenue obligations.*

*In Minute Order 110911, dated April 26, 2007, and as amended by subsequent minute orders, the Texas Transportation Commission adopted a free passage policy defining the circumstances under which free passage on Texas Department of Transportation toll projects and systems may be provided. This minute order will amend the free passage policy to (1) clarify that free passage for authorized emergency vehicles includes vehicles used by nonprofit disaster relief organizations, (2) clarify that the term "military vehicles" includes unmarked vehicles as defined by statute, (3) provide free passage for vehicles owned by disabled peace officers, and (4) delete duplicative provisions and make grammatical edits for clarity and readability.*

*The Texas Transportation Commission may authorize the Texas Department of Transportation (department) to issue notes or borrow money from any source to carry out the functions of the department. The adoption of this minute order would authorize the department to borrow directly from certain financial institutions for cash flow purposes.*

*The Texas Department of Transportation has established a separate fund to account for, and track projects and project costs funded with the SH 121 payments. This minute order authorizes the funding of additional projects or project costs and changes to the list of previously approved projects. The project costs to be funded were selected through a cooperative process with the Regional Transportation Council.*

- (2) **SH 161 - Various Counties** - Consider concurrence with the Regional Transportation Council of the North Central Texas Council of Governments' funding of construction and other project development costs of projects to be advanced through the use of payments received from the North Texas Tollway Authority in accordance with the SH 161 Toll Project Agreement ([MO](#))  
*The Texas Department of Transportation has established a separate fund to account for and track projects and project costs funded with the SH 161 payments. This minute order authorizes the funding of additional projects or project costs. The project costs to be funded were selected through a cooperative process with the Regional Transportation Council.*

- (3) **North Tarrant Express Segments 1 & 2 - Various Counties** - Consider concurrence with the Regional Transportation Council of the North Central Texas Council of Governments' funding of construction and other project development costs of projects to be advanced through the use of surplus toll revenue received in accordance with the North Tarrant Express Toll Project Agreement ([MO](#))  
*The Texas Department of Transportation has established a separate subaccount to account for and track projects and project costs funded with surplus toll revenue from the North Tarrant Express (NTE) Segments 1 and 2. This minute order authorizes the use of surplus toll revenues from the NTE Segments 1 & 2 Regional Toll Revenue subaccount for the funding of transportation projects proposed by the Regional Transportation Council of the North Central Texas Council of Governments, which were selected through a cooperative between the Texas Department of Transportation and the Regional Transportation Council.*

g. **Speed Zones**
