Contract award conditions may involve securing funding from other sources, the contractor's ability to satisfy statutory requirements, or other requirements as outlined in the project bid proposal.

Development of the 2027 Unified Transportation Program Planning Targets
([Presentation](#))

The Unified Transportation Program (UTP) is a 10-year statewide plan for transportation project development. The purpose of this presentation is to facilitate a discussion of the 2027 UTP planning targets and investment strategy. The outcome will be a guidance document to be distributed to Texas Department of Transportation districts, metropolitan planning organizations, and other planning partners for the development of the 2027 UTP.

The awards identified in this minute order reflect an allocation of state and federal Section 5311 Rural Areas Formula Grant Program funds to Community Services, Inc. for general public transportation, a reallocation of unused fiscal year 2021 federal Section 5339(b) Buses and Bus Facilities Competitive Program Funds to Capital Area Rural Transportation System for the purchase of fleet vehicles for the Electric Vehicle Pilot Program implementation and an allocation of federal Section 5304 Statewide and Nonmetropolitan Transportation Planning Program funds to Central Texas Rural Transit District for regional coordination planning activities.

Amendments to §2.201-2.206, and repeal of §2.207 concerning Memorandum of Understanding with the Texas Parks and Wildlife Department ([MO](#))
The proposed amendments to multiple rule sections and repeal of one rule section revise and update the Texas Department of Transportation's Memorandum of Understanding with the Texas Parks and Wildlife Department, which is required by Transportation Code §201.607.

117116 b. **Chapter 9 - Contract and Grant Management**
Amendments to §9.12-§9.15 and §9.17 concerning contracts for highway projects ([MO](#))
The proposed amendments extend the prequalification grace period to four months for all qualification levels, standardize language for clarity and consistency, clarify requirements for electronic bid bonds, allow the Texas Department of Transportation (department) to determine a bid nonresponsive if a discrepancy with a bidder certification is discovered prior to contract award, and document that the department may delay its notification of contract award pending resolution of necessary conditions.

c. Chapter 28 - Oversize and Overweight Vehicles and Loads

Amendments to §28.11, and §28.12(e), repealing the requirement for surety bonds to be approved by the Comptroller of Public Accounts and the Attorney General's Office ([MO](#))

The proposed amendments allow for Texas Department of Transportation (department) legal staff to review bonding requirements for Highway Crossing Agreements that allow the transport commodities or products from private property across a highway to another private property. These agreements are subject to review by the Area Office and prior to this rule required approval from the State Comptroller's Office and the Attorney General's Office. The proposed rule will streamline the process for applicants and ease department coordination.

10. **Eminent Domain**

Galveston County - Authorize condemnation of a parcel of land along the Gulf Intracoastal Waterway for dredge material placement ([MO](#))

This minute order authorizes the Texas Department of Transportation (department) to condemn a 255.881-acre parcel of land for the placement of material dredged from the Gulf Intracoastal Waterway and future beneficial use projects, in accordance with the department's role as the non-federal sponsor as designated by the Texas Coastal Waterways Act.

Various Counties - Consider the authorization of the filing of condemnation proceedings to acquire real property by eminent domain for non-controlled and controlled access highways ([MO](#)) (see attached itemized list)

Texas Transportation Commission findings, determinations, and authorizations for the state, by motion made in accordance with Senate Bill 18, 82nd Legislature, Regular Session, 2011, to acquire by eminent domain, upon the payment of adequate and just compensation, various ownership interests in specific parcels of real property that are needed to develop or improve both non-controlled and controlled access state highways, to include requesting the state attorney general to bring and pursue condemnation suits relating to those specific parcels of real property described in the attached itemized list.

a. **Donations to the Department**

Various Districts - Consider the acknowledgment of donations with a value of \$500 or more, including donations of money, materials, services, or real property, that are made to the Texas Department of Transportation (department) for the purpose of assisting the department in carrying out its functions and duties or for improving access to or from a highway on the state highway system ([MO](#)) (see attached itemized list)

State statutes require the Texas Transportation Commission (commission) to acknowledge the acceptance of a gift to the Texas Department of Transportation that is valued at \$500 or more. By the adoption of this minute order, the commission acknowledges the receipt and acceptance of the property specified in the minute order.

b. **Real Estate Dispositions**

The Texas Transportation Commission must approve the sales, transfers, and exchanges of state rights of way and other real properties that are no longer needed for a state highway purpose. It must also approve, accept, and acknowledge donations to the state of real property that is valued at \$500 or more.

(1) **Atascosa County** - SH 97 - Consider the quitclaim of right of way to an abutting landowner ([MO](#))

The district has recommended that the commission determine that the land is no longer needed for highway purposes. There is no record title to the property, and Atascosa County has requested the quitclaim of the tract to the abutter.

(2) **Austin County** - I 10 & FM 1458 - Consider the sale of right of way to an abutting landowner ([MO](#))

The district has recommended that the commission determine that the land is no longer needed for highway purposes. An abutting landowner has requested to purchase the land, and it may be sold to the requester.

(3) **Bexar County** - I 10 - Consider the exchange of a drainage easement as part of a transaction to acquire a drainage easement needed for a state highway purpose ([MO](#))

The district has recommended that the Texas Transportation Commission (commission) determine that the drainage easement to be conveyed by the State in the exchange is no longer needed for a state highway purpose.

(4) **Dallas County** - SL 12 - Consider the sale of right of way to an abutting landowner ([MO](#))

The district has recommended that the Texas Transportation Commission determine that the land is no longer needed for highway purposes. An abutting landowner has requested to purchase the land, and it may be sold to the requester.

(5) **Grimes County** - FM 244 - Consider a highway easement release to the underlying fee owner ([MO](#))

The district has recommended that the Texas Transportation Commission determine that the easement is no longer needed for highway purposes. The easement may be released to the underlying fee owner.

(6) **Tarrant County** - West Lancaster Avenue - Consider the sale of right of way to a governmental entity with the authority to condemn the property ([MO](#))

The district has recommended that the Texas Transportation Commission determine that the land is no longer needed for highway purposes. A governmental entity with the authority to condemn the property has requested to purchase the land, and it may be sold to the requester.

(7) **Tarrant County** - SH 26 - Consider the removal from the system, transfer of jurisdiction, control, and maintenance, and transfer of right of way to the city of Colleyville, Texas ([MO](#))

The district has recommended that the Texas Transportation Commission determine that a segment of roadway is no longer needed as part of the state highway system. The city of Colleyville (city) has agreed to assume jurisdiction, control, and maintenance and has requested that the right of way be transferred to the city. The right of way may be transferred to the city without cost to remain in use for public road purposes and will revert to the state if it ceases to be used for public road purposes, if the unrestricted motor vehicle lanes are reduced in number or width, or if the capacity of the roadway is reduced at all.

c. **Reports**

(1) **Compliance Division Report**

State law requires the Texas Transportation Commission (commission) to establish a compliance program, which must include a Compliance Division to oversee the program. The Compliance Division is responsible for acting to prevent and detect serious breaches of the Texas Department of Transportation (department) policy, fraud, waste, and abuse of office, including any acts of criminal department. The Compliance Division is required to provide a monthly report to the commission regarding investigations and a summary of information relating to trends and recommendations.

(2) **Letting Allocation Report**

Quarterly report on the fiscal year 2026-2027 letting allocation, the actual allocation utilized through the quarter, and proposed remaining highway maintenance and construction contract letting for the fiscal year ([Report](#))

This report will provide the current overall allocation status, by district and metropolitan planning organization, of the fiscal year 2026-2027 letting allocation and will also provide the anticipated effect on the letting allocation of remaining proposed highway maintenance and construction letting.

(3) **Quarterly Cash Report**

Quarterly report on fiscal year 2026 State Highway Fund 6 cash activity ([Report](#))

This report updates the commission on the year-to-date cash balance and activity of Fund 6. The report will include original projections and actual revenues/inflows and expenditures/outflows on a cash basis.

(4) **Short-term Borrowing Program Report**

Short-term Borrowing Program Report ([Report](#))

The Texas Department of Transportation is providing a report to the members of the Bond Review Board that summarizes the recent activity and anticipated future activity for the State Highway Fund Short-term Borrowing Program.

d. **Speed Zones**

Various Counties - Consider the establishment or alteration of regulatory and construction speed zones on various sections of highways in the state ([MO](#))
