This letter is being delivered to you in order to amend the Facility Concession Agreement for the SH 130, Segments 5 & 6 (FCA) dated March 22, 2007, between the Texas Department of Transportation (TxDOT) and SH 130 Concession Company, LLC (Developer). Initially capitalized terms not otherwise defined in this letter have the meanings given those terms in the FCA.

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, TxDOT and the Developer hereby agree as follows:

- 1. Item 2B.10 of Table A1-4 of Attachment 1 (Facility Management Plan Contents) to Book 2 Technical Requirements of the FCA is amended by deleting the requirement to provide the following deliverable item: "Describe procedures to collect and verify traffic and ridership data".
- 2. Item 2D.2 of Table A1-4 of Attachment 1 (Facility Management Plan Contents) to Book 2 Technical Requirements of the FCA is amended to require that the Developer obtain TxDOT's approval of the deliverable item (Provide description of the necessary offices and office equipment to be provided by Developer during the Operating Period) no later than May 31, 2009.
- 3. Item 2D.21 of Table A1-4 of Attachment 1 (Facility Management Plan Contents) to Book 2 Technical Requirements of the FCA is amended to require that the Developer obtain TxDOT's approval of the deliverable item (Provide Tolling Plan) no later than May 31, 2009.
- 4. As hereby amended the FCA is in full force and effect.
