April 2012	Environmental re-evaluation approved



4. SH 183 Managed Lanes Project

SH 183 • NTE 2E • SH 114 • LP 12

At November SB 1420 meeting, the Committee recommended analysis of a number of project combinations including the SH 183, NTE 2E, LP 12 and SH 114 (Short) as a toll concession

 - Standalone SH 183 as Design-Build
 - SH 183, NTE 2E, SH 114 (Short), LP 12 as Toll Concession



4. Combined SH 183 & SH 161 DB

At December SB 1420 meeting, the Committee recommended an analysis of a combined SH 161 and the initial scope of the SH 183 project as Design-Build

- Added SH 161 to the MTP for further processing
- □ SH 161 operational prior to 2018

4. New SH 183 Managed Lanes Project

- TxDOT moving forward with expanded scope based on industry feedback
- □ Texas Transportation Commission authorized issuance of an RFQ for SH 183 Managed Lanes Project at January 31, 2013 meeting
 - SH 183 and NTE Segment 2E
 - Additional connecting facilities
- New scope requires new SB 1420 Committee formation with opportunity for other eligible entities to participate
 - Tarrant County
 - City of Euless
 - City of Bedford
 - City of Ft. Worth

4. Presentation - SB 1420 Committee

Applicability of this Committee

- For a TxDOT toll project in which a private entity has a financial interest in the project's performance (i.e., under a concession agreement or an availability payment)
- Regional funding and/or county or municipal ROW or revenues will be provided to the project

Formation and Membership of Committee:

- NCTCOG (1 member)
- NTTA (1 member)
- County or Municipality (1 member each if applicable)
 - provided local funds to pay for right of way acquisition or other project costs or to acquire right of way for the project, or has provided property of the city or county for use as project right of way; or
 - submitted to the department an order or resolution adopted by the city council or county commissioners court committing local funds or property to the project; and
- TxDOT (1 member)

Officers

Committee will elect a chair and vice chair


4. Presentation - SB 1420 Committee

Duties

- Submit a report to the Executive Director of TxDOT that shall contain the following determinations:
 - Allocation of revenue risk
 - Method of financing for the project
 - Tolling structure and methodology
- Submit report by RFQ or RFP date, as applicable, or
 - TxDOT will use business terms adopted by the MPO and that relate to the determinations to be included in the report
- Meetings
 - Subject to Open Meetings requirements
 - Committee members can suggest agenda items
 - Quorum defined as one half or more of members appointed to the Committee
 - Only act on majority vote of members present

4. SH 183 Managed Lanes Project

Expanded Scope – SH 183 • NTE 2E • SH 114 • LP 12



4. New SH 183 Managed Lanes Project

- Expanded scope considered based on industry feedback
 - □ SH 183 NTE 2E other facilities for connectivity and financing purposes (may include portions of LP 12 and SH 114)
- Issue new RFQ
- Likely attracts more proposers
- Maximizes leverage of public funds

4. New SH 183 Managed Lanes Project


- Expanded SB 1420 Committee required
 - New members have been invited
 - First meeting February 14, 2013 at NCTCOG
- CDA Authority
 - Legislative authority required to add SH 114 and LP 12
- Primacy
 - NTTA will perform due diligence for SH 114 and LP 12
- Planning and Environmental
 - Coordinating 2013 plan amendment with NCTCOG
 - Coordinating environmental documents with FHWA
