
ITEM 11B. SH 288 TOLL LANES IN HARRIS COUNTY


Project Scope

- Design, construct, finance, operate and maintain a 10.3-mile segment of SH 288 from US 59 to the Harris County line for a 52 year term
- Initial Configuration includes:
 - 4-tolled lanes (2 each direction) within existing SH 288 median
 - New Beltway 8 interchange, all 8 direct connectors
 (DCs)
 - Texas Medical Center Connector, 2 DCs
 - ROW to ROW O&M including General Purpose Lanes



Additional Project Components

- Handback requirements at termination
- The Initial Configuration must accommodate the Ultimate Configuration of the Project which includes:
 - Improvements to the I-610 interchange
 - One additional General Purpose Lane on SH 288 in each direction from I-610 to Beltway 8



Evaluation of Proposals

- Implemented a pre-established and rigorous procedure to evaluate and select the proposal that offers the best value
- Separate pass/fail, technical and financial evaluations
- Evaluation subcommittees provided scoring recommendations to the Evaluation Selection Recommendation Committee (ESRC)
- ESRC provided scoring recommendations to the Project Steering Committee
- Project Steering Committee reviewed ESRC recommendations and made final recommendation to Commission

Apparent Best Value Determination

- Financial Score is the sum of the Price Score (max. 76 points) and the Termination for Convenience Fee Score (max. 4 points)
- Technical score is based upon the Evaluation Score for the Project Development Plan



Apparent Best Value = <u>Highest</u> Total Proposal Score

Evaluation Results Summary

Apparent Best Value Proposal consistent with the RFP includes:

- \$27.6 million upfront payment to TxDOT for the base scope
- Innovative ATCs within I 610 Interchange and other improvements to the project
- Operation and maintenance of new and existing lanes
- Tolling and revenue risk borne by the Developer
- Toll levels adjusted per SB 1420 recommendations to maintain 45 MPH average speed in the tolled lanes
- Interoperability drivers will be able to use any toll tag currently in use in Texas
- At the end of the concession term, road must still meet quality performance requirements established by TxDOT

Next Steps

- Negotiate final terms of Comprehensive Development Agreement (CDA)
- FHWA concurrence with award
- Legislative Budget Board reviews and issues written approval
- Attorney General concurrence of legal sufficiency
- Public Hearing to disclose project financial data prior to execution of the CDA
- Execute contract to develop, design, construct, finance, operate and maintain the project
- Final award and execution on or before August, 2015
- Financial Close on or before November, 2015
- Open to Traffic by end of 2018
