

## Digital Divide in Texas



- Federal Communications Commission (FCC) recently updated their definition of broadband.
  - Speed benchmark went from 25 megabits per second (Mbps) for download and 3 Mbps for upload to 100/20 Mbps.
- According to the latest version of the [FCC's National Broadband Map](#), Texas has:
    - 10,117,484 total locations.
    - 383,465 unserved locations.
    - 149,709 underserved locations.

## House Bill 5 (87R)

- Created the Broadband Development Office (BDO) at the Texas Comptroller of Public Accounts in 2021.
- Required the BDO to:
  - Create a state broadband plan (June 2022).
  - Create a broadband development map (January 2023).
    - Latest version published June 2024
  - Implement a program to administer broadband expansion grants
  - Serve as an information clearinghouse for state & federal funding opportunities in Texas.
- Created the BDO Board of Advisors
  - Chaired by Comptroller Glenn Hegar with eight appointed members

## Funding Streams

- State General Revenue
  - Broadband Infrastructure Fund (BIF)
  - \$1.5 billion
  - Support projects that expand and ensure access to reliable, high-speed broadband
- American Rescue Plan Act
  - Coronavirus Capital Projects Fund (CPF)
  - \$500.5 million
  - For capital broadband projects





## Funding Streams

- Infrastructure Investment and Jobs Act (IIJA)
  - Broadband, Equity, Access, and Deployment (BEAD) Program
    - \$3.3 billion
    - Support state-administered broadband infrastructure initiatives
  - State Digital Equity Capacity Grant Program
    - \$55.5 million
    - Support programs designed to ensure information technology capacity needed for participation in society
    - Additional funding is expected but has not yet been announced by NTIA.

## Technical Assistance Program (TAP)



- Empowering Texas counties through no-cost broadband planning support.
- \$7 million in CPF funds
- Thirty-two counties were awarded support.

## Bringing Online Opportunities to Texas (BOOT) Program

- Texas' first competitive broadband grant program aimed at funding infrastructure projects that bring broadband access to end users in eligible areas of the state.
- Awardees were notified June 3, 2024.
- \$11.4 million in CPF funds to connect:
  - 1,471 residential locations
  - 92 businesses
  - 15 community anchor institutions

## BOOT II Program

- Purpose is to support broadband infrastructure projects that bring high-speed, reliable internet service directly to eligible locations within 24 selected counties.
- Uses both state and federal funds (CPF) totaling \$729.9 million
- Potential to connect over 95,000 locations
- [BOOT II Notice of Fundin Availability \(NOFA\)](#) published on July 11, 2024
- First tranche of awardees notified on Nov. 18, 2024
- Second trance of awardees will be notified in the coming weeks

## Texas Broadband Pole Replacement Program

- The purpose is to provide reimbursement to eligible pole owners and broadband service providers for expenses related to replacing poles in rural areas.
- \$75 million in BIF funds
- Pole Replacement NOFA published on July 29, 2024.
- Accepted applications until Sept. 10, 2024.
- Awarded \$18.5 million in reimbursement requests
- Second NOFA published Nov. 4, 2024
- Applications to be accepted January 6 – 10, 2025
  - \$56.5 million remaining balance

# Broadband Equity, Access, and Deployment (BEAD) Program

- Administered by the National Telecommunications and Information Administration (NTIA).
  - BEAD Program
    - Close the availability gap
    - Nationwide investment of \$42.5 billion
    - Every state and territory received an allocation
    - Texas's Allocation: \$3.3 billion.
    - Required to connect every unserved and underserved location in the state
    - Fiber preference



## Broadband Infrastructure Fund (BIF)

- Much of the BIF will be dedicated to providing support to BEAD applicants with the 25 percent match requirement.
- The BDO is considering other allowable uses for the remaining BIF funds to include:
  - Connecting locations that may not be covered by the BEAD program, such as community anchor institutions (CAIs) and multi-dwelling units (MDUs).
  - Establishing a Texas Middle Mile program
  - Developing digital opportunity pilot programs
  - Support new and existing workforce development programs

## State Digital Equity Capacity Grant Program (SDECGP)

- The BDO received approval on its SDECGP application on November 21, 2024.
- The BDO was allocated \$55.5 million to support implementation of the Texas Digital Opportunity Plan (TDOP) and make competitive subawards.
- The approved application lists three activities to support implementation:
  - Establish a Digital Opportunity Grant Program
  - Grow and Sustain a Digital Opportunity Ecosystem
  - Maintain a Living Digital Opportunity Plan
- States have nine months from award date to identify subgrantees for SDECG funds. The period of performance lasts five years from award date.
- The BDO expects to share more on the subgrant opportunity in 2025.

## **TDOP: Covered Populations**

Federal legislation requires prioritizing improving outcomes for covered populations.  
85.6% of Texans belong to a covered population.

<b>Covered Population Group</b>	<b>Share of Texas Population</b>
<b>Members of a racial or ethnic minority group (racial or ethnic minorities)<sup>1</sup></b>	58%
<b>Individuals in households below 150% poverty (low-income households)<sup>1</sup></b>	23%
<b>Individuals residing in rural areas (rural residents)<sup>2</sup></b>	22%
<b>Persons who are 60 years of age or older (aging individuals)<sup>1</sup></b>	18%
<b>Individuals with disabilities<sup>1</sup></b>	11%
<b>Individuals with limited English proficiency (Individuals who speak English less than "very well" or have low levels of literacy)<sup>2</sup></b>	27%
<b>Veterans<sup>1</sup></b>	5%
<b>Incarcerated individuals<sup>2</sup></b>	1%

## TDOP: Goals

### Broadband Availability and Affordability

- All Texans have access to reliable, affordable internet service at home.

### Device Availability, Affordability and Technical Support

- All Texans have access to affordable internet-enabled devices in their home, with corresponding technical support services.

### Digital Literacy

- All Texans have a broad foundation of digital literacy skills and access to a continuum of digital skills development programs.

### Online Privacy and Cybersecurity

- All Texans feel safe online and are familiar with cybersecurity and online privacy measures.

### Online Accessibility and Inclusivity of Public Resources

- All Texans can utilize the internet for public resources and services.

## TDOP: Outcome Areas

### Education Access and Advancement

- Texas will have access to a higher quality education through online learning opportunities.

### Health Improvement

- Widespread broadband adoption will result in improved personal and community health across Texas.

### Accessibility of Essential Services

- Texans will have greater access to resources and tools that ensure effective use of public resources.

### Civic and Social Engagement

- Texans will be more connected to one another, their communities and their government with improved tools to participate in civic processes.

### Economic and Workforce Development

- The Texas economy will grow stronger and more resilient through a more skilled workforce.

## Multi-Dwelling Units (MDUs)

- The BDO seeks to address the broadband infrastructure and digital opportunity needs of Texans living in MDUs.
- BDO released a Request for Information (RFI) to gather feedback from knowledgeable entities on the landscape of broadband availability in MDUs.
  - 51 responses were collected from Oct. 1-22, 2024.
- The BDO is reviewing RFI responses and will use that information to inform a possible future grant program.
- The office anticipates sharing findings at a future monthly roundtable.

## Workforce Development

- The BDO is focused on strengthening ties with the telecommunications industry in effort to address any potential workforce deficits due to historic infrastructure buildout.
- The office recently published a [workforce development webpage](#) serving as an informational resource.
- The page highlights broadband workforce complications and job opportunities.
- The office is currently exploring opportunities and determining the best avenues for support.
